Speakers' Profiles

Mr. Jeffrey A. Apperson

Mr. Jeff Apperson is a court management professional dedicated to the effective administration of justice nationally and internationally, a lifetime goal that is reflected in his career. He has worked actively, on behalf of citizens of the United States and World, to promote and enhance access to forums that would protect the vulnerable, provide conflict resolution with dignity and fairness, and facilitate equal protection under law.

Jeff served as the Clerk of the United States Bankruptcy and District Courts for the Western District of Kentucky for 27 years. He also served as an attorney advisor to the U.S. Courts as a member of the Inspector General's Office and as Chief of Court Management for the United Nations International Criminal Tribunal for the Former Yugoslavia. He has held the position of Vice President for International Relations of the National Center for State Courts since January 2011. In this role, he has overseen the management of United States rule of law projects for Bangladesh, Iraq, Serbia, Kosovo, South Africa, Honduras, Columbia, Uganda, Nigeria, Belize, Guatemala, Panama, the Caribbean Basin, and Egypt.

He has travelled to over 60 countries in various capacities, giving speeches on rule of law topics in the supreme courts of Pakistan, Indonesia, Brazil, the Caribbean Court of Justice and the International Court of Justice in The Hague, among others. Jeff co-founded and served as president and CEO of the International Association for Court Administration (IACA). During his service with IACA, he managed nine international conferences dedicated to improving court management, access to justice and institutional transparency in Slovenia, Ireland, Italy, Turkey, Trinidad, Indonesia, the UAE, The Hague, and Argentina and helped establish the International Journal for Court Administration.

Jeff graduated from Samford University Law School and was a member of the Alabama Bar Association and United States Supreme Court Bar.



Madam Justice Irene Chirwa Mambilima is Zambia's first female Chief Justice. She was appointed in February 2015. Justice Mambilima holds a Bachelor of Laws Degree from the University of Zambia, a Post Graduate Diploma in Law Practice from the Law Practice Institute in Lusaka now known as the Zambia Institute of Advanced Legal Education (ZIALE), and a Masters of Laws Degree from the University of London.

She is a member of a number of professional associations, including the International Association of Women Judges, the Council of Law Reporting, Child Fund Zambia and the Advisory Board for Women in Law Southern Africa (WILSA). Since being admitted to the bar in1977, Justice Mambilima has worked in various capacities in Government including as a State Advocate under the Attorney General's Chambers and as the Director of Legal Aid in Zambia. She has also previously served as Deputy Chief Justice, Supreme Court Judge and High Court Judge.

As the Chairperson of the Electoral Commission of Zambia, she presided over the 2011 presidential and parliamentary elections and the 2015 presidential by-election.

Justice Mambilima has participated in various election observer missions in Mozambique, Kenya, Seychelles and she led the EISA Election Observation Mission to the presidential elections in Liberia. She has also attended various seminars, conferences and trainings in election management, alternative dispute resolution, gender and democracy and Judges Seminars.





Hon. Mr. Justice Nigel Kalonde Mutuna



Hon. Mr. Justice Nigel Kalonde Mutuna CIArb obtained his LLB degree from the University of Zambia in 1984 and was admitted to the Bar as a practitioner in 1985. From 1999 to 2009, he served as President for Zambia Association of Arbitrators.

Hon. Mr. Justice Mutuna completed a Special Member course, CIArb in 2002 and was admitted to membership, he also took the first step to Fellowship CIArb, Amsterdam in 2004 and is an accredited tutor CIArb, London. He served as Judge of the High Court Commercial List from 2009 until 2016 when he was appointed Judge of the Supreme Court of Zambia.

Hon. Mr. Justice Mutuna is the Chairperson of the Advisory Committee on Court Annexed Mediation and Delay Reduction.

Mr. Percy Kangwa Chato



Mr. Percy Kangwa Chato obtained his Bachelor of Social Work (BSW) degree from the University of Zambia in 1996 and later trained as a Prisons Cadet Officer at Prisons Staff Training College, Kabwe in 1998. He also obtained a Post-graduate Diploma in Human Rights Law from the University of Zambia in 2004 and attended a course in New Approaches to Management of Prisons in the 21st Century at Galilee College, Israel in 2005 as well as an Executive course in Security Sector Governance at the University of the Witwatersrand, Johannesburg, South Africa in 2007.

Mr. Chato has worked in the public sector at various levels. From 1999 to 2001, he held the rank of Assistant Superintendent and worked as Officer In-Charge Lusaka Remand Prison and Officer In-Charge Lusaka Central Prison. 2001 to 2002, Mr. Chato served as a Reformatory Superintendent at Katombora Reformatory School and later held the Rank of Senior Superintendent and served as Public Relations Officer-Prisons Headquarters between 2003 and 2004. While holding the rank of Assistant Commissioner from 2005 to 2007, he served as Director, Offender Management Unit-Prisons Headquarters, which subsequently saw him rise to the rank of Deputy Commissioner in 2009 to 2010 and held the office of Director Correctional Service and HIV/AIDS Coordinator-Prisons Headquarters. In 2010, he was elevated to Commissioner, Zambia Prisons Service, the position he held until 2015 and later promoted to Commissioner General in 2016 under the Zambia Correctional Service.

On international level Mr. Chato served under the United Nations Mission in Sudan (UNMIS) as Corrections Adviser-Operations from 2007 to 2009. He has also presented papers, some of which include the Zambia Prisons Service's 15 Point Agenda for Integration Human Rights Training and Observance in Prisons (30th October 2012 ICPA, Mexico City, Mexico, and Prisons Conditions and health care in prison settings (23th May 2016 Vienna – Austria), at international level as well as the African HIV/AIDS in Prisons Partnership (20th July 2016 Arusha – Tanzania) at regional level.

Hon. Mr. Justice Mwiinde J. Siavwapa

Hon. Justice Mwiinde J. Siavwapa holds a Diploma in Education, Magistrates' Diploma, Bachelor of Laws Degree from the University of Zambia and a Master of Laws Degree from the University of Wales.

He first trained as a Secondary School Teacher and taught at Njase Girls and Monze Boys Secondary Schools.

He was appointed Magistrate Class III and rose through the ranks to the position of Registrar of the High Court and acted as Chief Administrator of the Judiciary for 1 year 8 months before being appointed Deputy Chairman of the Industrial Relations Court on 8th February 2007.

In March 2010, Hon. Justice Siavwapa was appointed Judge of the High Court and is currently Judge-in-charge at Lusaka.



Mrs. Rosemary Nkonde Khuzwayo

Mrs. Rosemary Nkonde-Khuzwayo, the Chief State Advocate at the National Prosecution Authority has been practicing Law for almost 20 years, out of which 17 years has been in the criminal justice system.

She started work in 1996 as a Learner Legal Practitioner in the A.G. Chambers of the then Ministry of Legal Affairs and became a State Advocate in 1997 upon being called to the bar. In the 17 years of criminal law practice, Mrs. Khuzwayo has worked both under the office of the DPP and Legal Aid.

Before assuming her current office, Mrs. Khuzwayo was seconded to Ministry of Youth and Sport from 2012 to 2013 as Legal Counsel for the Zone VI Games. After her tour of duty there, she worked for the Judiciary under the Supreme Court as a Senior Researcher from 2013 to 2015.



Hon. Mr. Justice Charles Kajimanga



Hon. Mr. Justice Charles Kajimanga FCIArb obtained his LLB degree from the University of Zambia in 1983 and was admitted to the Bar in 1984. In 1993, he obtained his LLM degree from Cornell University (USA). He was appointed Judge of the High Court in 2002. In December 2015, he was appointed Judge of the Supreme Court.

Hon. Mr. Justice Kajimanga is a Fellow of the Chartered Institute of Arbitrators (England) and a member of the London Court of International Arbitration (African Users Council). Since 2006, he has been an approved tutor, examiner and assessor in arbitration courses offered by the Chartered Institute of Arbitrators in Zambia. He was the first Chairman of the Chartered Institute of Arbitrators Zambia Branch. He has presented papers at and attended arbitration conferences and seminars within and outside Zambia. Hon. Mr. Justice Kajimanga is a contributor of a chapter in a book entitled 'ARBITRATION IN AFRICA: A REVIEW OF KEY JURISDICTIONS' published by Sweet & Maxwell in 2016.

Hon. Justice Torgbor



Hon. Justice Edward Torgbor, CA, FCIArb, LLD, is currently a Specialist International and Chartered Arbitrator and Mediator based in Nairobi (Kenya), he is a Fellow of the Chartered Institute of Arbitrators (England) and Vice-President of the LCIA African Users' Council.

Judge Torgboris a former Barrister in England, Judge of the High Court of Kenya, Professor of Law (Stellenbosch University) and Court Member of the LCIA. He is an Advocate of the Supreme Court of Zambia, Attorney at Law, Ghana, CIArb Lecturer and Tutor in arbitration law and practice. He has published for professional journals in Africa and United Kingdom (the LCIA and Chartered Institute of Arbitrators). He has had various roles as Keynote Speaker, Chairman, Presenter and Resource Person at numerous arbitration conferences, seminars and workshops in various countries in Africa and Europe.

His specializations include: Domestic & International arbitration/ADR practice; International Trade & Investment Law; Corporate and Commercial Law; Energy and Natural Resources, Banking, and Designing regulatory frameworks for Public Sector reform, and governance facilitation.


He was lead Counsel for the Eastern and Central African Trade Development Bank (PTA Bank) and Legal Consultant for UNEP and UN-Habitat. He drafted a Framework Environmental Law for the Kingdom of Cambodia and compiled a Compendium of Judicial Decisions on Environmental Law under UNEP Consultancy, and wrote a Guidebook on "The Right to Adequate Housing" for UN-Habitat.

He is a law graduate from the Universities of Edinburgh, Cambridge and Stellenbosch, with many years

experience in the legal, judicial, academic fields, and in dispute resolution.



Vlad is admitted as an Attorney of the High Court of South Africa and a Solicitor of the Senior Courts of England and Wales. He has advised and acted for several re-nouned corporations such as the US Office of Foreign Assets Control regulations, the Helen Suzman Foundation, Airports Company South Africa Ltd, and the Anglo American Group to mention but a few.

Vlad is a member of the Law Society of the Northern Provinces, Law Society of the Cape of Good Hope and the Law Society of England and Wales, 2009 to date. Mr. Abyudi J. Shonga Jnr., SC






In the year 2000, he obtained a Master of Laws Degree (LLM) from the University of Zambia with his thesis on "The Judicature, Judges, Judicial Autonomy and Independence: Threats to Autonomy and Independence, Realities and Challenges".

He served in various government portfolio from 1970, such as Public Prosecutor attached to Ministry of Legal Affairs. He also worked as State Advocate, Assistant Senior State Advocate and eventually elevated to Senior State Advocate in the Attorney-General's Chambers,

In 1975, Chief Justice Ernest L. Sakala (Rtd) was appointed Director of Public Prosecutions and later on in 1977 appointed to the bench as Judge of the High Court. He was elevated to the Supreme Court bench in 1985. In 1988, he was moved to the position of Investigator-General, Commission for Investigations, a position he held until 1989 when he was re-appointed Supreme Court Judge. He acted as Deputy Chief Justice from April 2000 to May 2001 and eventually appointed Chief Justice in 2002.

Justice Sakala (Rtd) has been a member of the Comesa Court of Justice since 2005. He has also served as Chairperson, Parliamentary and Ministerial Code of Conduct Tribunals, Tribunal of Inquiry appointed under the Judicature provisions of the Constitution of Zimbabwe, Committee drafting Judicial Code of Conduct for the Judiciary.

Chief Justice Sakala (Rtd) also served Acting Chairperson for the Southern African Chief Justices forum from 2007 to 2009 and later a Chairperson from 2009 to 2011, when he retired.
