### INTERNAL EMPLOYMENT OPPORTUNITIES

Further to the Judicial Service Commission Advertisement No. 1 of 2025 dated 24<sup>th</sup> March, 2025, and pursuant to Article 140 of the Constitution, Chapter 1 of Laws of Zambia as amended by the Constitution of Zambia (Amendment) Act No. 2 of 2016 ("the Constitution"), the Judicial Service Commission invites applications from suitably qualified candidates **currently serving within the Judiciary** to be recommended for appointment as Judges of the Court of Appeal or High Court. (20 positions)

## 1. POSITION: COURT OF APPEAL JUDGE

#### Job Purpose

To ensure that judicial authority of the Republic of Zambia is exercised in accordance with Article 118 of the Constitution.

### **Key Responsibilities**

- a) Hear and adjudicate on civil and criminal cases involving intricate legal issues.
- b) Manage courtroom proceedings to ensure adherence to legal procedures and fairness.
- c) Deliver judgments and rulings within strict timelines based on sound legal reasoning and interpretation of the law.
- d) Discharge judicial functions in accordance with the principles outlined in Article 118(2) of the Constitution as follows:

- i. justice shall be done to all, without discrimination;
- ii. justice shall not be delayed;
- iii. adequate compensation shall be awarded, where payable;
- iv. alternative forms of dispute resolution, including traditional dispute resolution mechanisms, shall be promoted;
- v. justice shall be administered without undue regard to procedural technicalities; and
- vi. the values and principles of the Constitution shall be protected and promoted.

- b) A minimum of twelve (12) years' professional experience postqualification as a legal practitioner in the Republic of Zambia.

- b) Outstanding written and oral communication skills, with an ability to engage diplomatically inside and outside court settings.

- d) Collaborative decision-making skills.
- e) Capacity to efficiently process large volumes of information and conduct in-depth legal research.
- f) Resilience, adaptability and ability to work under pressure.
- g) Commitment to delivering justice efficiently within strict timeframes.
- h) Commitment to public service.
- i) Willingness to serve anywhere in the Republic of Zambia.
- j) Leadership and Managerial skills.
- k) Medically fit.
